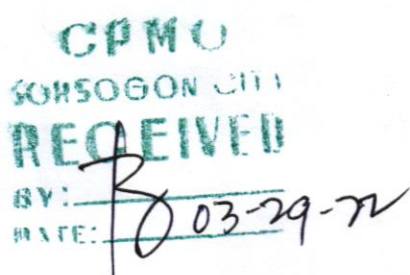
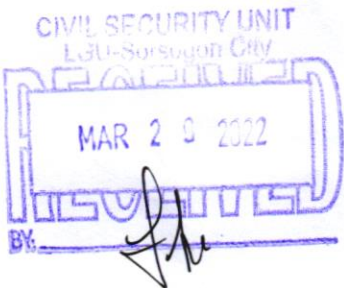

CONTRACT AGREEMENT

THIS AGREEMENT made this **25th** day of **March**, **2022** between **Ma. Ester E. Hamor**, **City Mayor, City of Sorsogon** Philippines (hereinafter called the " Entity") of the one part and **MILAGROS D. LIAO** proprietor of **BIG B ENTERPRISES** (hereinafter called the "Supplier") of the other part:

- ii. Winning bidder's bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted;



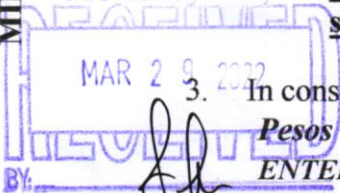

4. The City Government of Sorsogon agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.






