

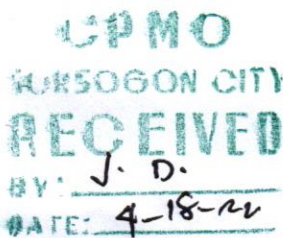

## CONTRACT AGREEMENT

THIS AGREEMENT made this **8th** day of **April**, **2022** between **Ma. Ester E. Hamor**, City Mayor, City of Sorsogon Philippines ( hereinafter called the “ Entity” ) of the one part and **. 



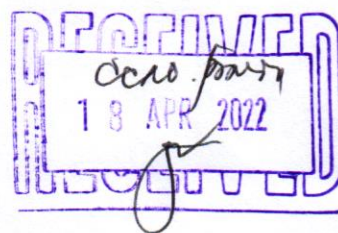
