

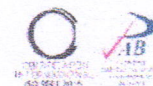

CONTRACT AGREEMENT

THIS AGREEMENT made this **5th** day of **May**, **2023** between **Ma. Ester E. Hamor**, City Mayor, City of Sorsogon Philippines (hereinafter called the “ Entity ”) of the one part and **AGNES TAN** Authorized Representative of **JEANEE’S SUPERMART & DEPARTMENT STORE, INC.** (hereinafter called the “Supplier”) of the other part:

Bid form, including all the documents/statements contained in the Bidder’s bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder’s response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity’s bid evaluation;
- iii. Performance Security;
- iv. Notice of Award of Contract; and the Bidder’s conforme thereto; and

In consideration for the sum of **Seven Hundred Fifty One Thousand Five Hundred Pesos (P 751,500.00) Only** or such other sums as may be ascertained, **JEANEE’S SUPERMART & DEPARTMENT STORE, INC.** agrees to viz **SUPPLY AND DELIVERY OF VARIOUS FOOD ITEMS USED DURING THE VARIOUS MEETINGS** in accordance with his/her/its Bid.



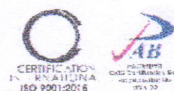
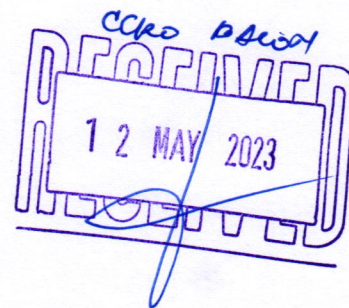
