### Contract Agreement No. B- 2024-0522-GS

THIS AGREEMENT made this 7<sup>th</sup> day of June , 2024 between Ma. Ester E. Hamor, City Mayor, City of Sorsogon Philippines (hereinafter called the "Entity") of the one part and MR. MARCOS E. PARAS, JR Proprietor of Sorsogon Today (hereinafter called the "Supplier") of the other part:

WHEREAS the Entity invited Bids for certain goods and ancillary services, viz **PUBLICATION OF** FOUR (4) CITY ORDINANCES and has accepted a Bid by the Supplier for the supply of those goods and services in the sum of **Two Million Four Hundred Eighty Four Thousand and Three Pesos** ( **P** 2,484,003.00 ) Only (hereinafter called "the Contract Price").

- iii. Performance Security;
- iv. Notice of Award of Contract; and the Bidder's conforme thereto; and
- v. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. <u>Winning bidder agrees that</u> <u>additional contract documents or information prescribed by the GPPB</u> <u>that are subsequently required for submission after the contract execution,</u> <u>such as the Notice to Proceed, Variation Orders, and Warranty Security,</u> <u>shall likewise form part of the Contract.</u>

3. In consideration for the sum of **Two Million Four Hundred Eighty Four Thousand and Three Pesos (P 2,484,003.00) Only** or such other sums as may be ascertained, **Sorsogon Today** agrees to **PUBLICATION OF FOUR (4) CITY ORDINANCES** in accordance with his/her/its Bid.

4. The <u>*City Government of Sorsogon*</u> agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.
