CONTRACT AGREEMENT

THIS AGREEMENT made this 9th day of May, 2024 between Ma. Ester E. Hamor, City Mayor, City of Sorsogon Philippines (hereinafter called the "Entity") of the one part and JUDITH A. TUMALAD Proprietress of JAD MARKETING (hereinafter called the "Supplier") of the other part:

WHEREAS the Entity invited Bids for certain goods and ancillary services, viz **RENTAL OF TABLES AND CHAIRS FOR THE BACON STREET DANCE COMPETITION FOR THE 2024 GAYON BACON CELEBRATION** and has accepted a Bid by the Supplier for the supply of those goods and services in the sum *One Hundred Sixty-Two Thousand Seven Hundred Pesos & 0/100 (P 162,700.00) Only* (hereinafter called "the Contract Price").

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

Notice of Award of Contract; and the Bidder's conforme thereto; and

Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. <u>Winning bidder agrees that</u> additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.
