CONSTRUCTION OF LINE CANAL PHASE II @ City Village, Brgy. Cabid-an, East Dist. Sor. City <u>CW 2024-07-013</u>

- The City Government of Sorsogon, through the Trust Fund DRRMF intends to apply the sum of One Million Eight Hundred Eighty-Seven Thousand Six Hundred Twenty-Seven & 92/100 Pesos (₱ 1,887,627.92) Only being the total Approved Budget for the Contract (ABC) to payments under the contract for CONSTRUCTION OF LINE CANAL PHASE II @ City Village, Brgy. Cabid-an, East Dist. Sor. City under Project Reference No. CW 2024-07-013 . Bids received in excess of the ABC shall be automatically rejected at bid opening.
- 2. The *City Government of Sorsogon* now invites bids for the above Procurement Project. Completion of the Works is required *within <u>120 calendar days</u>*. Bidders should have completed a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).
- 3. Bidding will be conducted through open competitive bidding procedures using nondiscretionary "*pass/fail*" criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.
- 4. Interested bidders may obtain further information from *Bids and Awards Committee of the City Government of Sorsogon* and inspect the Bidding Documents at the address given below from 9:00A.M to 3:00 PM Only.
- 5. A complete set of Bidding Documents may be acquired by interested bidders on *July 3*, 2024 from given address and website/s <u>sorsogoncity.gov.ph</u> and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of *Five Thousand Pesos* (*P 5,000.00*). The Procuring Entity shall allow the bidder to present its proof of payment for the fees.
- 6. The *City Government of Sorsogon* will hold a Pre-Bid Conference¹ on *July 11, 2024 at 9:00am* at *BAC Office*, *City Hall, Cabid-an, East District, Sorsogon City* which shall be open to prospective bidders however **SHALL** observed compliance with the requirements stipulated in the ITB.
- 7. Bids must be duly received by the BAC Secretariat on *July 24, 2024 at 8:00 A.M* through the authorized representative of the bidder . Late bids shall not be accepted.
- 8. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB** Clause 15.
- 9. Bid opening shall be on *July 24, 2024 at 9:00 A.M* at the given address below .Bids will be opened in the presence of the bidders' representatives who choose to attend the activity.

¹ May be deleted in case the ABC is less than One Million Pesos (PhP1,000,000) where the Procuring Entity may not hold a prebid conference.
