- The City Government of Sorsogon now invites bids for the above Procurement Project. Delivery of the Goods is required by within **(90) Ninety Calendar Days** . Bidders should have completed, within (2) years from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II of the Instructions to Bidders.
- Bidding will be conducted through open competitive bidding procedures using a non-discretionary *“pass/fail”* criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.
 - Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA No. 5183.
- Prospective Bidders may obtain further information from *the City Government Bids and Award Committee* and inspect the Bidding Documents at the address given below from **9:00 AM to 3:00PM only**.
- A complete set of Bidding Documents may be acquired by interested Bidders on **July 3, 2024** from the given address and website(s) below *and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of **Five Thousand (Php 5,000.00) Pesos per LOT***. The Procuring Entity shall allow the bidder to present its proof of payment for the fees *after payment has been made* .
