## CONTRACT AGREEMENT

THIS AGREEMENT made this 25th day of April, 2024 between Ma. Ester E. Hamor, City Mayor, City of Sorsogon Philippines ( hereinafter called the " Entity" ) of the one part and LORENA DUKA TONO Proprietress of **DUKA'S OFFICE AND SCHOOL SUPPLIES (** hereinafter called the "Supplier" ) of the other part:

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

- 1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.
- 2. CITY MAYOR COLLY MAYOR The following documents as required by the 2016 revised Implementing Rules and Regulations of Republic Act No. 9184 shall be deemed to form and be read and construed as integral part of this Agreement, viz .:
  - i. Philippine Bidding Documents (PBDs):
    - Schedule of Requirements; i.
    - ii. Technical Specifications;
    - General and Special Conditions of Contract; and iii.
    - Supplemental or Bid Bulletins, if any iv.

Winning bidder's bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted;

Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;

iii. Performance Security;

Notice of Award of Contract; and the Bidder's conforme thereto; and

Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.

I la IL consideration for the sum of One Hundred Seventy Thousand Pesos & 0/100 (Php 170,000.00 ) Only or such other sums as may be ascertained, 2024 DUKA'S ICE AND SCHOOL SUPPLIES agrees to SUPPLY AND DELIVERY OF EQUIPMENT AND OTHER OFFICE EQUIPMENT FOR CITY SSESSOR'S OFFICE in accordance with his/her/its Bid.

4. The <u>*City Government of Sorsogon*</u> agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.
