CONTRACT AGREEMENT

THIS AGREEMENT, made this 8th day of August, 2024 between CITY GOVERNMENT OF SORSOGON, City Hall, Cabid-an East Dist. Sorsogon City (hereinafter called the "Entity") and STEVEN CONSTRUCTION & SUPPLY with office address Lot 6, Blk 1 Central City, Subd. Tahao Road, Cruzada Legaspi City (hereinafter called the "Contractor").

WHEREAS, the Entity is desirous that the Contractor execute CONSTRUCTION OF FARM TO MARKET ROAD L-3 (Brgy. San Vicente Bacon District Sorsogon City) under Contract Reference No. CW 2024-05-009L-3 (hereinafter called "the Works") and the Entity has accepted the Bid for Four Million Eighty Three Thousand Twenty Nine and 56/100 Pesos (Php 4,083,029.56) Only by the Contractor for the execution and completion of such Works and the remedying of any defects therein.

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement, words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract hereinafter referred to.

Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;

- c. Performance Security;
- d. Notice of Award of Contract and the Bidder's conforme thereto; and
- e. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.

In consideration for the sum of Four Million Eighty Three Thousand Twenty Nine and 56/100 Pesos (Php 4,083,029.56) Only or such other sums as may be ascertained, STEVEN CONSTRUCTION & SUPPLY agrees to CONSTRUCTION OF FARM TO MARKET ROAD L-3 (Brgy. San Vicente Bacon District Sorsogon City) in accordance with his/her/its Bid.


