CONTRACT AGREEMENT

THIS AGREEMENT made this 26th day of July, 2024 between Ma. Ester E. Hamor, City Mayor, City of Sorsogon Philippines (hereinafter called the "Entity") of the one part and IRISH J. JAZMIN Proprietress of IJ & J ENTERPRISES (hereinafter called the "Supplier") of the other part:

 - Winning bidder's bid, including the Eligibility requirements, Technical and ii. Financial Proposals, and all other documents or statements submitted;

Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;

Performance Security;

PUBLIC MARKET INFICENOTICE of Award of Contract; and the Bidder's conforme thereto; and -Sorsogon Cr

> Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.

ZARD onsideration for the sum of One Hundred Thirty-Eight Thousand Pesos & 2024 0/100 (Php 138,000.00) Only or such other sums as may be ascertained, IJ & J **ENTERPRISES** agrees to SUPPLY AND DELIVERY OF OFFICE SUPPLIES FOR THE OFFICE OF COUNCILOR DANILO DELADIA in accordance with his/her/its Bid.

4. The <u>City Government of Sorsogon</u> agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.
