

CONTRACT AGREEMENT

THIS AGREEMENT made this **9th** day of **May, 2024** between **Ma. Ester E. Hamor**, City Mayor, City of Sorsogon Philippines (hereinafter called the " Entity") of the one part and **MA. CRISTINA E. DURAN** Proprietress of **PAOPAO HOTEL AND RESIDENCES** (hereinafter called the "Supplier") of the other part:

WHEREAS the Entity invited Bids for certain goods and ancillary services, viz **CATERING SERVICES FOR THE DIFFERENT ACTIVITY OF THE 2024 GAYON BACON ACTIVITY** and has accepted a Bid by the Supplier for the supply of those goods and services in the sum of **Two Hundred Thirty-Five Thousand Eight Hundred Eighty-Five Pesos & 0/100 (Php 235,885.00) Only** (hereinafter called "the Contract Price").

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

 - ii. Technical Specifications;
 - iii. General and Special Conditions of Contract; and
 - iv. Supplemental or Bid Bulletins, if any

Winning bidder's bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted;

Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;



Performance Security;

Notice of Award of Contract; and the Bidder's conforme thereto; and

Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. **Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.**

In consideration for the sum of **Two Hundred Thirty-Five Thousand Eight Hundred Eighty-Five Pesos & 0/100 (Php 235,885.00) Only** or such other sums as may be ascertained, **PAOPAO HOTEL AND RESIDENCES** agrees to **CATERING SERVICES FOR THE DIFFERENT ACTIVITY OF THE 2024 GAYON BACON ACTIVITY** in accordance with his/her/its Bid.




