### **CONTRACT AGREEMENT**

THIS AGREEMENT made this 4th day of June, 2024 between Ma. Ester E. Hamor, City Mayor, City of Sorsogon Philippines ( hereinafter called the " Entity" ) of the one part and JUDITH A. TUMALAD Proprietress of JAD MARKETING (hereinafter called the "Supplier") of the other part:

WHEREAS the Entity invited Bids for certain goods and ancillary services, viz **RENTAL OF** TABLES AND CHAIRS AND OTHER EQUIPMENT FOR A 15-DAY GAYON CIUDAD TRADE FAIR IN CELEBRATION OF THE 2024 GAYON CIUDAD FESTIVAL and has accepted a Bid by the Supplier for the supply of those goods and services in the sum Three Hundred Thirty-Five Thousand Six Hundred Pesos & 0/100 ( ₱ 335,600.00) Only (hereinafter called "the Contract Price").

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

- 1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.

- ii. Winning bidder's bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted; ACEIN SATELITE OFFICE-CSU

Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;

CITY PUBLIC MARKET OFFICE Performance Security;

Notice of Award of Contract; and the Bidder's conforme thereto; and

Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.

In consideration for the sum of Three Hundred Thirty-Five Thousand Six Hundred TUPE & 0/100 ( P 335,600.00) Only or such other sums as may be ascertained, agrees to the RENTAL OF TABLES AND CHAIRS AND JAD MARKETING OTHER EQUIPMENT FOR A 15-DAY GAYON CIUDAD TRADE FAIR IN **CELEBRATION OF THE 2024 GAYON CIUDAD FESTIVAL** in accordance with 1. t. /l. . . /t. D. 1

4. The <u>*City Government of Sorsogon*</u> agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.
