CONTRACT AGREEMENT

THIS AGREEMENT made this 2nd day of August, 2024 between Ma. Ester E. Hamor , City Mayor, City of Sorsogon Philippines (hereinafter called the "Entity") of the one part and **ALWAYNE DEAN MATEOS DELIGERO** Authorized Partner of **BLACKPAJAMA** COMPANY (hereinafter called the "Supplier") of the other part:

- ii. Winning bidder's bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted; BACON SATELITE OFFICE-CSU

Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;

Performance Security;

Notice of Award of Contract; and the Bidder's conforme thereto; and

Other contract documents that may be required by existing laws and/or the ocuring Entity concerned in the PBDs. Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.

EWEU consideration for the sum of Fifty-One Thousand One Hundred Thirty-Nine 2024 Pasos & 0/100 (P 51,139.00) Only or such other sums as may be ascertained, AUG 0 ACKPAJAMA COMPANY agrees to viz BA SUPPLY AND DELIVERY OF MATERIALS FOR USE IN THE IMPROVEMENT OF ROMPEOLAS BY: SORSOGON CITY SIGNAGE in accordance with his/her/its Bid.

4. The <u>*City Government of Sorsogon*</u> agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.
