

CONTRACT AGREEMENT

THIS AGREEMENT made this 16th day of August, 2024 between Ma. Ester E. Hamor , City Mayor, City of Sorsogon Philippines (hereinafter called the "Entity") of the one part and MA. ELENA T. MORADA Proprietress of 38MJ ENTERPRISES (hereinafter called the "Supplier") of the other part:

- Winning bidder's bid, including the Eligibility requirements, Technical and ii. Financial Proposals, and all other documents or statements submitted; ON SATELITE OFFICE-CSU

Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;

Notice of Award of Contract; and the Bidder's conforme thereto; and

Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.

n consideration for the sum of One Hundred Forty-Five Thousand Six Hundred Sixty-Two Pesos & 0/100 (Php 145,662.00) Only or such other sums as may be ascertained, 38MJ ENTERPRISES_ agrees to SUPPLY AND DELIVERY OF MATERIALS FOR USE IN THE IMPROVEMENT OF SLAUGHTERHOUSE EQUIPMENT & FACILITIES in accordance with his/her/its Bid.

4. The <u>City Government of Sorsogon</u> agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.
