THIS AGREEMENT, made this <u>4th</u> day of <u>October</u>, <u>2024</u> between CITY GOVERNMENT OF SORSOGON, City Hall, Cabid-an East Dist. Sorsogon City (hereinafter called the "Entity") and ALHADRAX CONSTRUCTION & SUPPLY with office address Maningay De Oro, Prieto Diaz, Sorsogon (hereinafter called the "Contractor").

WHEREAS, the Entity is desirous that the Contractor execute <u>CONSTRUCTION OF FARM</u> <u>RO MARKET ROAD (BOGNA-CARICARAN) @ Brgy. Bogña Bacon District Sorsogon</u> City under Contract Reference No. CW 2024-07-016 (hereinafter called "the Works") and the Entity has accepted the Bid for <u>Two Million Nine Hundred Seventy Thousand Pesos (Php 2,970,000.00)</u> <u>Only</u> by the Contractor for the execution and completion of such Works and the remedying of any defects therein.

- e. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. <u>Winning bidder agrees that additional</u> <u>contract documents or information prescribed by the GPPB that are</u> <u>subsequently required for submission after the contract execution, such as</u> <u>the Notice to Proceed, Variation Orders, and Warranty Security, shall</u> <u>likewise form part of the Contract.</u>

In consideration for the sum of <u>*Two Million Nine Hundred Seventy Thousand*</u> <u>*Pesos (Php 2,970,000.00) Only*</u> or such other sums as may be ascertained, ALHADRAX CONSTRUCTION & SUPPLY agrees to <u>*CONSTRUCTION OF*</u> <u>*FARM RO MARKET ROAD (BOGNA-CARICARAN) @ Brgy. Bogña Bacon District*</u> <u>*Sorsogon* in accordance with his/her/its Bid.</u>
