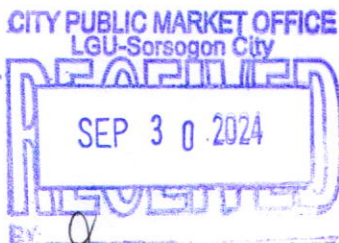

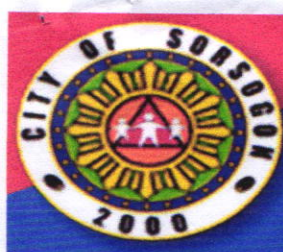

THIS AGREEMENT made this 19th day of September, 2024 between Ma. Ester E. Hamor, City Mayor, City of Sorsogon Philippines (hereinafter called the " Entity") of the one part and MR. ALWAYNE DEAN DELIGERO Proprietor of BLACKPAJAMA COMPANY (hereinafter called the "Supplier") of the other part:

WHEREAS the Entity invited Bids for certain goods and ancillary services, viz SUPPLY AND DELIVERY OF DESKTOP COMPUTERS and has accepted a Bid by the Supplier for the supply of those goods and services in the sum of Two Million Nine Hundred Eighty Nine Thousand Eight Hundred Pesos (₱ 2,989,800.00) Only (hereinafter called "the Contract Price").

- iii. Performance Security;

Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. **Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.**

3. In consideration for the sum of Two Million Nine Hundred Eighty Nine Thousand Eight Hundred Pesos (₱ 2,989,800.00) Only or such other sums as may be ascertained, BLACKPAJAMA COMPANY agrees SUPPLY AND DELIVERY OF DESKTOP COMPUTERS in accordance with his/her/its Bid.

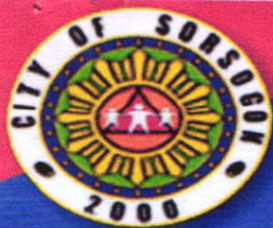
