CONTRACT AGREEMENT

THIS AGREEMENT made this 27th day of June, 2024 between Ma. Ester E. Hamor, City Mayor, City of Sorsogon Philippines (hereinafter called the "Entity") of the one part and JENNY VI F. CANLAS Proprietress of J. CANLAS AUTO PARTS (hereinafter called the "Supplier") of the other part:

The <u>*City Government of Sorsogon*</u> agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.
