### **CONTRACT AGREEMENT**

THIS AGREEMENT made this 16th day of August, 2024 between Ma. Ester E. Hamor, City Mayor, City of Sorsogon Philippines (hereinafter called the "Entity") of the one part and JOSEPH MARK M. PARAS Authorized Representative / Signatory of SORSOGON TODAY (hereinafter called the "Supplier") of the other part:

TY PUBLIC MARKEY OFFINIOTICE of Award of Contract; and the Bidder's conforme thereto; and

Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. <u>Winning bidder agrees that</u> additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.
