### CONTRACT AGREEMENT

THIS AGREEMENT made this **30th** day of **August, 2024** between **Ma. Ester E. Hamor**, **City Mayor, City of Sorsogon** Philippines (hereinafter called the "Entity") of the one part and **RYAN BELLEZA** Branch Manager/Authorized Signatory of hereinafter called the "Supplier") of the other part:

Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. <u>Winning bidder agrees that</u> <u>additional contract documents or information prescribed by the GPPB</u> <u>that are subsequently required for submission after the contract execution,</u> <u>such as the Notice to Proceed, Variation Orders, and Warranty Security,</u> <u>shall likewise form part of the Contract.</u>

Seven Pesos & 0/100 ( P 109,267.00 ) Only or such other sums as may be ascertained, DENVER'S COMPUTER SHOPPE, INC. agrees to viz SUPPLY & DELIVERY OF VARIOUS OFFICE EQUIPMENT FOR SUBSIDY TO BARANGAY in accordance with his/her/its Bid. 4. The <u>*City Government of Sorsogon*</u> agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.
