



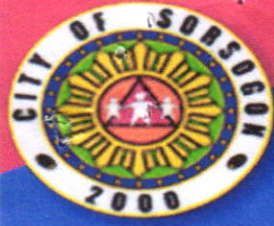

## CONTRACT AGREEMENT

THIS AGREEMENT made this **30th** day of **August, 2024** between **Ma. Ester E. 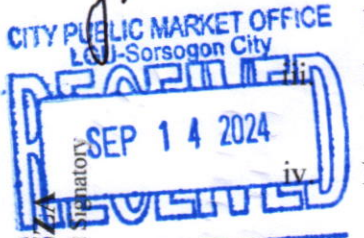
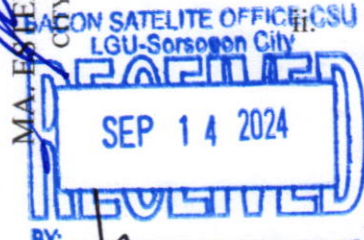
