CONTRACT AGREEMENT

Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. <u>Winning bidder agrees that additional</u> <u>contract documents or information prescribed by the GPPB that are</u> <u>subsequently required for submission after the contract execution, such as</u> <u>the Notice to Proceed, Variation Orders, and Warranty Security, shall</u> <u>likewise form part of the Contract.</u>
- f. Winning bidder shall present Tax Clearance(for Collection) from the Bureau of Internal Revenue as well as a copy of Business and Income Tax returns duly stamped and received by Bureau of Internal Revenue duly validated with the tax payment made thereon.
