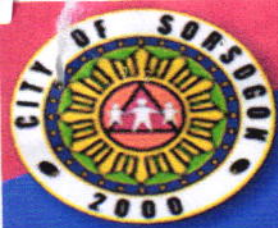

CONTRACT AGREEMENT

THIS AGREEMENT, made this 11th day of September, 2024 between CITY GOVERNMENT OF SORSOGON, City Hall, Cabid-an East Dist. Sorsogon City (hereinafter called the "Entity") and AZLJ CONSTRUCTION with office address Sorsogon City Employees Village, Cabid-an East District Sorsogon City (hereinafter called the "Contractor").

WITNESS

WHEREAS, the Entity is desirous that the Contractor execute **CONSTRUCTION OF OPEN LINE CANAL @ SITIO CENTRO, IRAYA & BLISS MACABOG WEST DISTRICT** under Contract Reference No. CW 2024-07-014 (hereinafter called "the Works") and the Entity has accepted the Bid for **Two Million Four Hundred Ninety Thousand and 37/100 Pesos (Php 2,490,000.37) Only** by the Contractor for the execution and completion of such Works and the remedying of any defects therein.

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement, words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract hereinafter referred to.
2. The following documents as required by the 2016 revised Implementing Rules and Regulations of Republic Act No. 9184 shall be deemed to form and be read and construed as part of this Agreement, viz.:

- a. Philippine Bidding Documents (PBDs);
 - i. Drawings/Plans;
 - ii. Specifications;
 - iii. Bill of Quantities;
 - iv. General and Special Conditions of Contract;
 - v. Supplemental or Bid Bulletins, if any;
- b. Winning bidder's bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted;

Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;

- c. Performance Security;
- d. Notice of Award of Contract and the Bidder's conforme thereto; and
- e. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. **Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.**

3. In consideration for the sum of **Two Million Four Hundred Ninety Thousand and 37/100 Pesos (Php 2,490,000.37) Only** or such other sums as may be ascertained, AZLJ CONSTRUCTION agrees to **CONSTRUCTION OF OPEN LINE CANAL @ SITIO CENTRO, IRAYA & BLISS MACABOG WEST DISTRICT** in accordance with his/her/its Bid.



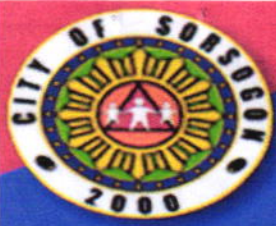
