THIS AGREEMENT made this **2nd** day of **August, 2024** between **Ma. Ester E. Hamor**, **City Mayor, City of Sorsogon** Philippines (hereinafter called the " Entity") of the one part and **JENNY VI F. CANLAS** Proprietress of **J. CANLAS AUTO PARTS** (hereinafter called the "Supplier") of the other part:

WHEREAS the Entity invited Bids for certain goods and ancillary services, viz **SUPPLY AND DELIVERY OF VARIOUS SPARE PARTS AND CONSUMABLES FOR DIFFERENT GOVERNMENT VEHICLE FOR AUGUST 2024** and has accepted a Bid by the Supplier for the supply of those goods and services in the sum **One Hundred Thirteen Thousand Nine Hundred Thirty Pesos & 0/100 (₱ 113,930.00) Only** (hereinafter called "the Contract Price").

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.

 - ii. Technical Specifications;
 - iii. General and Special Conditions of Contract; and
 - iv. Supplemental or Bid Bulletins, if any
- ii. Winning bidder's bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted;

Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;

iii. Performance Security;

iv. Notice of Award of Contract; and the Bidder's conforme thereto; and

v. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. **Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.**

3. In consideration for the sum of **One Hundred Thirteen Thousand Nine Hundred Thirty Pesos & 0/100 (₱ 113,930.00) Only** or such other sums as may be ascertained, **J. CANLAS AUTO PARTS** agrees to viz **SUPPLY AND DELIVERY OF VARIOUS SPARE PARTS AND CONSUMABLES FOR DIFFERENT GOVERNMENT VEHICLE FOR AUGUST 2024** in accordance with his/her/its Bid.
