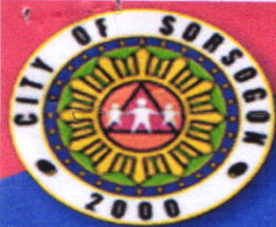

CONTRACT AGREEMENT

THIS AGREEMENT made this **13th** day of **September, 2024** between **Ma. Ester E. Hamor**, City Mayor, City of Sorsogon Philippines (hereinafter called the " Entity") of the one part and **ERLENA D. BENZON** Proprietress of **ERL PHARMA** (hereinafter called the "Supplier") of the other part:

WHEREAS the Entity invited Bids for certain goods and ancillary services, viz **SUPPLY AND DELIVERY OF ANTI RABIES VACCINE** and has accepted a Bid by the Supplier for the supply of those goods and services in the sum **Two Hundred Ninety-Seven Thousand Five Hundred Pesos (Php 297,500.00) & 0/100 Only** (hereinafter called "the Contract Price").

- ii. Winning bidder's bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted;

Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;

iii. Performance Security;

Notice of Award of Contract; and the Bidder's conforme thereto; and

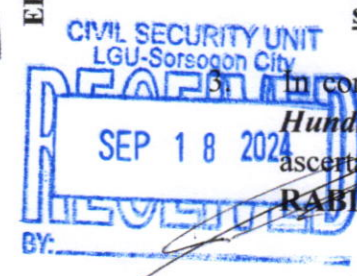
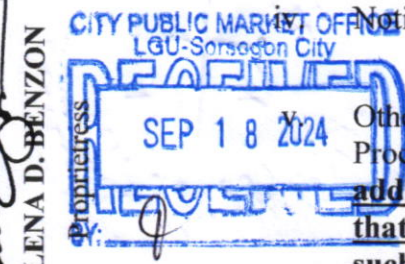
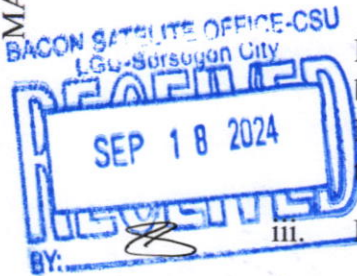
