Contract Agreement Form for the Procurement of Infrastructure Projects (Revised) <u>No. B- 2024-11-1392CW</u> CONTRACT AGREEMENT

THIS AGREEMENT, made this <u>6th</u> day of <u>December</u>, <u>2024</u> between CITY GOVERNMENT OF SORSOGON, City Hall, Cabid-an East Dist. Sorsogon City (hereinafter called the "Entity") and ALHADRAX CONSTRUCTION & SUPPLY with office address Maningay De Oro, Prieto Diaz, Sorsogon (hereinafter called the "Contractor").

WHEREAS, the Entity is desirous that the Contractor execute <u>REBLOCKING OF ROAD</u> @ <u>Brgy. Guinlajon West District Sorsogon City</u> under Contract Reference No. CW 2024-10-023 (hereinafter called "the Works") and the Entity has accepted the Bid for *One Million Nine Hundred Eighty Thousand Pesos (Php 1,980,000.00) Only* by the Contractor for the execution and completion of such Works and the remedying of any defects therein.

- e. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. <u>Winning bidder agrees that additional</u> <u>contract documents or information prescribed by the GPPB that are</u> <u>subsequently required for submission after the contract execution, such as</u> <u>the Notice to Proceed, Variation Orders, and Warranty Security, shall</u> <u>likewise form part of the Contract.</u>
- f. Winning bidder shall present Tax Clearance(for Collection) from the Bureau of Internal Revenue as well as a copy of Business and Income Tax returns duly stamped and received by Bureau of Internal Revenue duly validated with the tax payment made thereon.
