

### CONTRACT AGREEMENT

THIS AGREEMENT made this 27th day of June, 2024 between Ma. Ester E. Hamor, City Mayor, City of Sorsogon Philippines ( hereinafter called the " Entity" ) of the one part and DENNIS B. DURAN Jr. Proprietor of AUTO-MOTO ZONE ENTERPRISES (hereinafter called the "Supplier" ) of the other part:
