### **CONTRACT AGREEMENT**

THIS AGREEMENT made this 4th day of October, 2024 between Ma. Ester E. Hamor , City Mayor, City of Sorsogon Philippines ( hereinafter called the " Entity" ) of the one part and JOANNA MABELLE M. BELTRAN Proprietress of JMBEL ENTERPRISES (hereinafter called the "Supplier" ) of the other part:

Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;

Performance Security;

Notice of Award of Contract; and the Bidder's conforme thereto; and PUBLIC MARKET OFFICE

Procuring Entity concerned in the PBDs. Winning bidder agrees that ditional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.

The City Government of Sorsogon agrees to pay the above-mentioned sum in 4. accordance with the terms of the Bidding.
