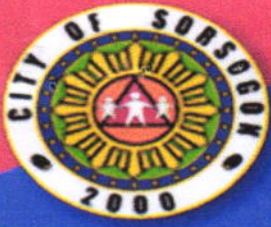

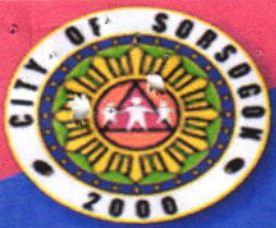

THIS AGREEMENT made this **16th** day of **August, 2024** between **Ma. Ester E. 
