CONTRACT AGREEMENT

THIS AGREEMENT made this 5th day of September, 2024 between Ma. Ester E. Hamor, City Mayor, City of Sorsogon Philippines (hereinafter called the "Entity") of the one part and ABIGAIL CHRIS C. TRAYVILLA Proprietress of TUKURAN TIRES AND BATTERY SUPPLIES (hereinafter called the "Supplier") of the other part:

WHEREAS the Entity invited Bids for certain goods and ancillary services, viz SUPPLY & DELIVERY OF VARIOUS TIRES FOR DIFFERENT GOVERNMENT VEHICLE FOR THE MONTH OF SEPTEMBER and has accepted a Bid by the Supplier for the supply of those goods and services in the sum *One Hundred Nine Thousand Eight Hundred Pesos & 0/100 (P 109,800.00) Only* (hereinafter called "the Contract Price").

Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. <u>Winning bidder agrees that</u> additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.
