CONTRACT AGREEMENT

THIS AGREEMENT made this 20th day of November, 2024 between Ma. Ester E. Hamor, City Mayor, City of Sorsogon Philippines (hereinafter called the " Entity") of the one part and OLIVER F. > Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;

Performance Security;

Notice of Award of Contract; and the Bidder's conforme thereto; and

Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.

B. Consideration for the sum of Seven Hundred Ninety-Six Thousand Nine 2024 Hundred Ninety Pesos & 0/100 (P 796,990.00) Only or such other sums as may be NOV 22 ascertained, ASHTROVIA MEDICAL TRADING CORPORATION agrees to viz SUPPLY AND DELIVERY OF MEDICAL SUPPLIES FOR STOCKPILING FOR BASIC EMERGENCY NEEDS OF CDRRMO, in accordance with his/her/its Bid.

4. The <u>*City Government of Sorsogon*</u> agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.
