### CONTRACT AGREEMENT

THIS AGREEMENT made this 5th day of December, 2024 between Ma. Ester E. Hamor , City Mayor, City of Sorsogon Philippines ( hereinafter called the " Entity" ) of the one part and JOSE BONIFACIO L. LASALA proprietor of JL ENTERPRISES ( hereinafter called the "Supplier" ) of the other part:
