## RENOVATION OF DRRMO / EOC BUILDING City Hall Grounds, Brgy. Cabid-an, East District CW 2025-07-007

- The City Government of Sorsogon, through Trust Fund intends to apply the sum of Nine Million Eight Hundred Eighty-Seven Thousand Six Hundred Ninety-Six & 66/100 (₱ 9,887,696.66) Only being the total Approved Budget for the Contract (ABC) to payments under the contract for RENOVATION OF DRRMO / EOC BUILDING City Hall Grounds, Brgy. Cabid-an, East District under Project Reference No. CW 2025-07-007. Bids received in excess of the ABC shall be automatically rejected at bid opening.
- The City Government of Sorsogon now invites bids for the above Procurement Project. Completion of the Works is required within <u>120 calendar days</u>. Bidders should have completed a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).
- 3. Bidding will be conducted through open competitive bidding procedures using non-discretionary *"pass/fail"* criterion as specified in the 2025 Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 12009 or The New Government Procurement Act.
- 4. Interested bidders may obtain further information from *Bids and Awards Committee of the City Government of Sorsogon* and inspect the Bidding Documents at the address given below from *9:00A.M to 3:00 PM Only.*
- A complete set of Bidding Documents may be acquired by interested bidders on July 1, 2025 from given address and website/s <u>sorsogoncity.gov.ph</u> and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of <u>Ten Thousand Pesos</u> (P 10,000.00). The Procuring Entity shall allow the bidder to present its proof of payment for the fees
- 6. The *City Government of Sorsogon* will hold a Pre-Bid Conference<sup>1</sup> on *July 9, 2025 at 9:00am* at *BAC Office*, *City Hall, Cabid-an, East District, Sorsogon City* which shall be open to prospective bidders however **SHALL** observed compliance with the requirements stipulated in the ITB.
- 7. Bids must be duly received by the BAC Secretariat on *July 22, 2025 at 2:00 P.M* through the authorized representative of the bidder. Late bids shall not be accepted.
- 8. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB** Clause 15.
- 9. Bid opening shall be on *July 22, 2025 at 3:00 P.M* at the given address below. Bids will be opened in the presence of the bidders' representatives who choose to attend the activity.
- 10. Contract will be awarded to the bidder with Lowest Calculated and Responsive Bid.
