## INVITATION FOR NEGOTIATED PROCUREMENT DUE TO TWO-FAILED BIDDINGS

# SUPPLY AND DELIVERY OF PICK-UP TRUCK VEHICLE FOR BFP GS 2025-07-012-NP

- The City Government of Sorsogon through the funds under the *General Fund*, intends to apply the sum of <u>One Million Three Hundred Three Thousand Pesos & O/100</u> (PhP 1,303,000.00) Only, being the Approved Budget for the Contract (ABC) to payments under the contract for the SUPPLY AND DELIVERY OF PICK-UP TRUCK VEHICLE FOR BFP.
- 2. The procurement procedure for this procurement project is Negotiated Procurement due to two (2) failed biddings pursuant to Section 35.1 of the 2025 Implementing Rules and Regulations (IRR) of Republic Act No. 12009 (RA 12009), otherwise known as the "The New Government Procurement Act", including Annex "H" thereof. The procurement is restricted to Filipino citizens/sole proprietorships, organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organization of a country the laws or regulations of which grant similar rights to privileges to Filipino citizens, pursuant to Republic Act 5183 (RA 5183) and subject to Commonwealth Act 138 (CA 138). The selection of the successful offer shall be based on the best and final offer that will be submitted on a specified date, which could meet the technical specifications specified by the end user.
- 3. The City Government of Sorsogon, through its Bids and Awards Committee (BAC), now invites technically, legally, and financially capable suppliers for the mentioned goods. The BAC shall invite at least three (3) suppliers, contractors or consultants, including those disqualified in previous biddings for the project, for negotiations to ensure effective competition. Even if only one (1) bidder should respond to such invitation or posting, the BAC shall proceed with the negotiation subject to the rules prescribed hereunder.
- 4. The BAC shall observe the same process and set the new periods according to the same rules followed during the previous bidding(s).
- 5. Interested Bidders may obtain further information from the BAC Secretariat at the address given below from Monday to Friday at 8:00 a.m. to 5:00 p.m.

The City Government of Sorsogon reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Section 70 of RA 12009 and its 2025 IRR or The New Government Act, without thereby incurring any liability to the affected bidder or bidders.
