



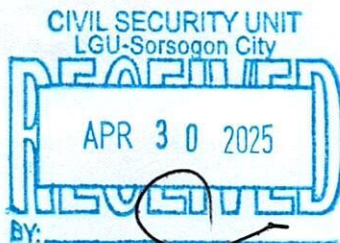

CONTRACT AGREEMENT

Contract No. 2025- 393 SVP

THIS AGREEMENT made this 25th day of April , 2025 between **Ma. Ester E. Hamor , City Mayor, City of Sorsogon Philippines** (hereinafter called the “ Entity”) of the one part and **JUDITH M. DOLLISON** Authorized Representative of **WRITESHOP ENTERPRISES** (hereinafter called the “Supplier”) of the other part:

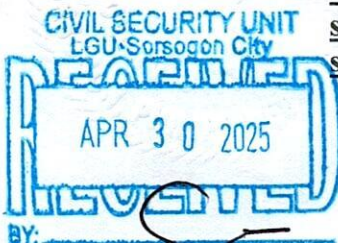
WHEREAS the Entity invited Bids for certain goods and ancillary services, viz **SUPPLY AND DELIVERY OF OFFICE SUPPLIES FOR CHO-WEST DISTRICT** during the State of Health Emergency and has accepted a Bid by the Supplier for the supply of those goods and services in the sum **Eighty Five Thousand Nine Hundred Fifty Six and 35/100 Pesos (₱ 85,956.35)) Only** (hereinafter called “the Contract Price”).

1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.

 - ii. Technical Specifications;
 - iii. General and Special Conditions of Contract; and
 - iv. Supplemental or Bid Bulletins, if any
 - ii. Winning bidder’s bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted;
 - iii. Performance Security;
 - iv. Notice of Award of Contract; and the Bidder’s conforme thereto; and
 - v. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. **Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.**





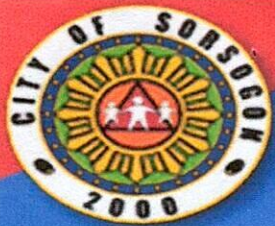
