1. The *City Government of Sorsogon*, through the *Trust Fund* from the Department of Agriculture and a counterpart from the *City Government of Sorsogon* through the Tanging Yaman Program intends to apply the sum of *Six Million Six Hundred Twenty Six Thousand Eight Hundred Fifty Two Pesos & 19/100 (Php 6,626,852.19)* being the Approved Budget for the Contract (ABC) to payments under the contract for the *CONSTRUCTION OF FOOD TERMINAL @ SPPVS BARANGAY BIBINCAHAN EAST DIST* under Project Reference No. *CW 2021-10-038*. Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The *City Government of Sorsogon* now invites bids for the above Procurement Project. Completion of the Works is required *with in 126 calendar days*. Bidders should have completed a contract similar to the Project equivalent to 50% of the Approved Budget for the contract to be bid. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).
3. Bidding will be conducted through open competitive bidding procedures using non-discretionary “*pass/fail*” criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.
4. Interested bidders may obtain further information from *Bids and Awards Committee of the City Government of Sorsogon* and inspect the Bidding Documents at the address given below from *9:00A.M to 3:00 PM Only*.
5. A complete set of Bidding Documents may be acquired by interested bidders on *October 6, 2021* from given address and website/s sorsogoncity.gov.ph and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of **Ten Thousand (P 10,000.00)**. The Procuring Entity shall allow the bidder to present its proof of payment for the fees *in person*.
6. The *City Government of Sorsogon* will hold a Pre-Bid Conference¹ on *October 14, 2021:9:00 am* at *BAC Office, City Hall, Cabid-an, East District, Sorsogon City* which shall be open to prospective bidders provided compliant with the Provincial Government Guidelines on COVID19 precautionary measures issued under EO No. 22 in relation to IATF protocol.
7. Bids must be duly received by the BAC Secretariat on *October 27, 2021* at 8:00 AM through the **authorized representative** of the bidder @ the Bids and Awards Committee, City Hall Cabid-an East Dist. Sorsogon City. Late bids shall not be accepted.
8. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB** Clause 15.

¹ May be deleted in case the ABC is less than One Million Pesos (PhP1,000,000) where the Procuring Entity may not hold a pre-bid conference.



9. Bid opening shall be on *October 27, 2021@ 9AM* at the given address below .Bids will be opened in the presence of the bidders' representatives who choose to attend the activity however shall be compliant with the health protocol being observed .

10. The *City Government of Sorsogon* reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Sections 35.6 and 41 of the 2016 revised Implementing Rules and Regulations (IRR) of RA No. 9184, without thereby incurring any liability to the affected bidder or bidders.
