

### CONTRACT AGREEMENT

THIS AGREEMENT, made this 13<sup>th</sup> day of August, 2021 between CITY GOVERNMENT OF SORSOGON, City Hall, Cabid-an East Dist. Sorsogon City (hereinafter called the "Entity") and DTM CONSTRUCTION with office address Unit 6,7 & 8 Ground Floor DTM Building, Quezon Street Polvorista, East Dist., Sorsogon City (hereinafter called the "Contractor").
