THIS AGREEMENT made this **10th** day of **September**, 2020 between **Ma. Ester E. Hamor**, City Mayor, City of Sorsogon Philippines (hereinafter called the " Entity") of the one part and **MR. RAFAEL N. MORALEDA** Proprietor of **RNM AGRO./INDUSTRIAL SUPPLY & GENERAL MERCHANDISE** (hereinafter called the "Supplier") of the other part:

WHEREAS the Entity invited Bids for certain goods and ancillary services, viz **SUPPLY AND DELIVERY OF HI-VALUE CROP SEEDS FOR THE CITY AGRICULTURE OFFICE** and has accepted a Bid by the Supplier for the supply of those goods and services in the sum of **One Million Three Hundred Eighty Two Thousand One Hundred Eighty (P 1,382,180.00) Only** (hereinafter called "the Contract Price").

 - iv. Notice of Award of Contract; and the Bidder's conforme thereto; and
 - v. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. **Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.**

In consideration for the sum of **One Million Three Hundred Eighty Two Thousand One Hundred Eighty (P 1,382,180.00) Only** or such other sums as may be ascertained, **RNM AGRO./INDUSTRIAL SUPPLY & GENERAL MERCHANDISE** agrees to **SUPPLY AND DELIVERY OF HI-VALUE CROP SEEDS FOR THE CITY AGRICULTURE OFFICE** in accordance with his/her/its Bid.






