THIS AGREEMENT made this 17th day of September , 2021 between Ma. Ester E. Hamor , City Mayor, City of Sorsogon Philippines (hereinafter called the "Entity") of the one part and MS. JOANNA MABELLE M. BELTRAN Proprietor of JMBEL Enterprises (hereinafter called the "Supplier") of the other part:

- iii. Performance Security;
- iv. Notice of Award of Contract; and the Bidder's conforme thereto; and
- v. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. <u>Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.</u>

In consideration for the sum of *Five Million Three Hundred Seven Thousand* Seven Hundred Eighty Nine (P 5,307,789.00) Only or such other sums as may be ascertained, JMBel Enterprises agrees to *PROVISION FOR RAINCOAT FOR THE YCAP ASSISTANCE PROGRAM OF SORSOGON CITY* in accordance with his/her/its Bid.
