RESOLUTION MOST RESPECTFULLY REQUESTING THE PROGRAM MANAGER OF GAYON SORSOGON TO SET UP TRASH BINS IN ALL STRATEGIC LOCATIONS WITHIN THE PREMISES OF ROMPEOLAS AND ALONG THE COASTAL ROADS OF THE CITY OF SORSOGON

WHEREAS, Rompeolas located at Barangay Talisay and the whole stretch of coastal road connecting thereto has been now considered as the most visited places in the city of Sorsogon, particularly during nighttime;

WHEREAS, being the most visited tourist destination in the city, proper waste disposal should be vigorously implemented to maintain the cleanliness and sanitary condition of the area;

WHEREAS, the existing policies and efforts of the city government would not be sufficient to provide and maintain clean streets and sidewalks in the said area without the help, cooperation and participation of the residents, visitors and dwellers thereof;

WHEREAS, the cleanliness, orderliness and sanitation of the alleys and sidewalks along the said areas encourage and attract business investors and tourists;

WHEREAS, Republic Act No. 9003, otherwise known as the Ecological Solid Waste Management Act of 2009, which states that it is the policy of the state to adopt a comprehensive and ecological solid waste management program which shall institutionalize public participation in the development and implementation of local integrated, comprehensive, and ecological waste management;

WHEREAS, every local government unit shall exercise the powers expressly granted, those necessarily implied therefrom; as well as powers necessary, appropriate or incidental for its efficient and effective governance and those which are essential to the **promotion of the general welfare**. Within their respective territorial jurisdiction, local government units shall ensure and support, among other things, the preservation and enrichment of culture, **promote health and safety**, improve public morals, enhance economic prosperity and social justice, maintain peace and order and **preserve the comfort and convenience of their inhabitant**;

NOW THEREFORE, on motion of **Hon. Jo Abegail C. Dioneda**, duly seconded by the **Hon. Mary Ellen D. Jamisola**, resolved as it is hereby resolve to pass a resolution to respectfully request the Program Manager of Gayon Sorsogon to set up trash bins in all strategic locations within the premises of Rompeolas and along the coastal roads of the city of Sorsogon.
