RESOLUTION ADOPTING SANGGUNIANG PANLALAWIGAN RESOLUTION NO 569, SERIES OF 2020 DATED DECEMBER 07, 2020 ENTITLED “RESOLUTION URGING THE CITY AND MUNICIPALITIES IN THE PROVINCE OF SORSOGON SURROUNDING THE SORSOGON BAY AND THE BUREAU OF FISHERIES AND AQUATIC RESOURCES (BFAR) TO IMPLEMENT STRICT REGULATIONS ON THE GATHERING AND SELLING OF SEASHELLS (I.E., TAHONG, BADUY, BALUKO AND OTHER RELATED SPECIES) ON ACCOUNT OF THE DECLARATION OF BFAR RO5 OF RED TIDE IN SORSOGON BAY

WHEREAS, laboratory examination conducted by the Bureau of Fisheries and Aquatic Resources using the Reveal Test Kit, shellfish samples collected in Sorsogon Bay are found to be positive of Paralytic Shellfish Toxin (PST) or commonly known as Red Tide;

WHEREAS, therein stated also are marine products identified to be temporarily banned from gathering and collecting such as seashells (i.e., Tahong, Baduy, Baluko and other related Species) which in turn may pose health risk when consumed on occurrence of Red Tide in the Sorsogon Bay Area;

WHEREAS, foregoing premise considered and after due deliberation on the matter, the 7th City Council deemed it necessary to pass a resolution adopting Sangguniang Panlalawigan Resolution No. 569, series of 2020 dated December 07, 2020 entitled "Resolution urging the City and Municipalities in the Province of Sorsogon surrounding the Sorsogon Bay and the Bureau of Fisheries and Aquatic Resources (BFAR) to implement Strict Regulations on the Gathering and Selling of Seashells (i.e., Tahong, Baduy, Baluko and other related Species) on account of the Declaration of BFAR RO5 of Red Tide in Sorsogon Bay;
