EVELINA G. ESCUDERO, REPRESENTATIVE, 1<sup>ST</sup> CONGRESSIONAL DISTRICT, PROVINCE OF SORSOGON, PROVINCIAL GOVERNMENT OF SORSOGON, SANGGUNIANG PANLALAWIGAN, CITY GOVERNMENT OF SORSOGON, CITY PLANNING AND DEVELOPMENT OFFICE, CITY DISASTER RISK REDUCTION AND MANAGEMENT OFFICE AND CITY ENGINEER'S OFFICE THE REQUEST FOR ASSISTANCE OF BARANGAY COUNCIL OF BARANGAY PIOT, WEST DISTRICT, SORSOGON CITY TO FACILITATE DREDGING, WIDENING OF AND CONSTRUCTION OF RIVER CONTROL FACILITY AT THE LONE OUTLET OF THE MERGING ANAHAW PIOT AND KALUNDAN RIVERS TO MINIMIZE FLOODING AT BARANGAY PIOT, SORSOGON CITY

WHEREAS, on December 17, 2020, Hon. Daniel F. Gonzales, Punong Barangay, Barangay Piot, West District, Sorsogon City submitted Barangay Resolution No. 081 addressed to the Hon. Mark Eric C. Dioneda, City Vice Mayor, Sorsogon City for the kind consideration of

the legislative department entitled "Resolution recommending to and Requesting Assistance from the Department of Public Works and Highways (DPWH)- First Engineering District, Province of Sorsogon, Department of Environment and Natural Resources (DENR), Department of the Interior and Local Government (DILG), Hon. Evelina G. Escudero, Representative, 1st Congressional District, Province of Sorsogon, Provincial Government of Sorsogon, Sangguniang Panlalawigan, City Government of Sorsogon, City Planning and Development Office, City Disaster Risk Reduction and Management Office and City Engineer's Office the request for Assistance of Barangay Council of Barangay Piot, West District, Sorsogon City to facilitate dredging, widening of and Construction of River Control Facility at the Lone Outlet of the Merging Anahaw Piot and Kalundan Rivers to Minimize Flooding at Barangay Piot, Sorsogon City";
