RESOLUTION AUTHORIZING THE HON. MA. ESTER E. HAMOR, CITY MAYOR, SORSOGON CITY TO ENTER INTO A MEMORANDUM OF AGREEMENT (MOA) WITH THE PHILIPPINE STATISTICS AUTHORITY (PSA) RELATIVE TO THE IMPLEMENTATION OF THE PHILIPPINE IDENTIFICATION SYSTEM (PHILSYS) IN THE CITY OF SORSOGON.

WHEREAS, among the items deliberated during the January 19, 2020 Regular Session of the 7th City Council is the letter-request from the Chief Executive requesting for a passage of a resolution authorizing the same to enter into a Memorandum of Agreement (MOA) with the Philippine Statistics Authority (PSA) relative to the implementation of the Philippine Identification System (PhilSys);

WHEREAS, the Philippine Statistics Authority (PSA) coordinated with the City Government relative to the Philippine Identification System (PhilSys), a single national identification system intended to register all Filipinos and resident aliens residing in the Philippines;

WHEREAS, their collaboration with the City Government is mandated by RA 11055 otherwise known as PhilSys Act to ensure that all citizens, residents aliens, indigenous and remote communities are registered and enrolled under the PhilSys;

WHEREAS, attached to the letter request is a copy of Memorandum of Agreement (MOA) for further perusal of the 7^{th} City Council;

WHEREAS, foregoing premises considered and after due deliberation on the matter, the 7th City Council deemed it necessary to pass a resolution authorizing the Hon. Ma. Ester E. Hamor, City Mayor, Sorsogon City to enter into a Memorandum of Agreement (MOA) with the Philippine Statistics Authority (PSA) relative to the implementation of the Philippine Identification System (PhilSys) in the City of Sorsogon.

NOW THEREFORE, on motion of **Hon. Hilario D. Dioneda**, duly seconded by **Hon. Ralph Walter R. Lubiano**, resolved as it is hereby resolve to authorize the Hon. Ma. Ester E. Hamor, City Mayor, Sorsogon City to enter into a Memorandum of Agreement (MOA) with the Philippine Statistics Authority (PSA) relative to the implementation of the Philippine Identification System (PhilSys) in the City of Sorsogon.
