RESOLUTION EXPRESSING COMPLIANCE AND ADOPTION TO THE PROVINCIAL BUDGET OFFICER (PBO) FINDINGS AND OBSERVATIONS IN RELATION TO APPROPRIATION ORDINANCE NO. 25, SERIES OF 2020 OF THE CITY GOVERNMENT OF SORSOGON INVOLVING THE SORSOGON CITY ANNUAL BUDGET CY 2021 IN THE AMOUNT OF ONE BILLION TWO HUNDRED TWO MILLION ONE HUNDRED EIGHTY THOUSAND NINE HUNDRED THREE AND 39/100 (P1,202,180,903.39)
