RESOLUTION AUTHORIZING HON. CITY MAYOR MA. ESTER E. HAMOR TO ENTER INTO A MEMORANDUM OF AGREEMENT WITH A CONSULTANCY FIRM FOR THE IMPLEMENTATION OF ISO 9001: QUALITY MANAGEMENT SYSTEM AND FOR THE CITY GOVERNMENT TO BE CERTIFIED THEREWITH SUBJECT TO THE PROVISIONS OF RA 9184 OTHERWISE KNOWN AS THE GOVERNMENT PROCUREMENT REFORM ACT

WHEREAS, the Provincial Government of Sorsogon through Hon. Governor Francis Joseph “Chiz” Escudero aims to have all government agencies within the province be certified under ISO 9001: Quality Management System;

WHEREAS, to become an ISO certified institution is very much aligned with the city government’s unyielding advocacy to provide quality service that shall greatly contribute to the improvement of the quality of life of every Sorsogonan;

WHEREAS, to fast track the implementation of ISO 9001 within the city government and to guide the city government in ensuing the same, the latter have opted to solicit the assistance of ISO consultancy firm;

WHEREAS, the City Government shall engaged the services of a ISO consultancy firm in the amount of Three Million and Five Hundred (P 3,500,000.00) Pesos for a period of six (6) months or less to commence from February 2021 to July 2021, however, the city government may at any time terminate the contract for justifiable reason/s;

NOW THEREFORE, on motion of **Hon. Nestor J. Baldon**, duly seconded by **Hon. Fernando David H. Duran, III**, resolve as it is hereby resolved to authorize Hon. Ma. Ester E. Hamor, City Mayor, Sorsogon City to enter into a Memorandum of Agreement with a consultancy firm for the implementation of ISO 9001: Quality Management System and for the city government to be certified therewith subject to the provisions of RA 9184 otherwise known as the Government Procurement Reform Act.
