**RESOLUTION ENACTING AN ORDINANCE ESTABLISHING BIKE RACKS IN IDENTIFIED STRATEGIC LOCATIONS IN THE CITY OF SORSOGON.**

**WHEREAS**, the Department of the Interior and Local Government (DILG) issued a Memorandum Circular in relation to establishment of cycling lanes in identified locations of their respective localities;

**WHEREAS**, corollary thereto, establishment of Cycling Lanes would encourage our local constituents to use bicycles as a mode of transportation aside from being a healthy habit, economical;

**WHEREAS**, this prompted the Hon. Mark Eric C. Dioneda, City Vice Mayor to propose the above titled ordinance purposely to protect the interest of bike enthusiasts against bike theft by providing bike racks in strategic locations of the locality;

**WHEREAS**, installation of bike racks would further enhance public safety and minimize traffic congestion along busy streets in our locality;

**WHEREAS**, following the required procedure in the passage of an ordinance, public hearing and consultation was conducted with the presence of stakeholders wherein full discussion and deliberation on the matter was made;

**WHEREAS**, foregoing premise considered and after due deliberation on the matter, the 7<sup>th</sup> City Council deemed it necessary to pass a resolution Enacting An Ordinance Establishing Bike Racks In Identified Strategic Locations In The City Of Sorsogon;

**NOW THEREFORE**, on motion of **HON. FRANCO ERIC O. RAVANILLA**, duly seconded by **HON. RALPH WALTER R. LUBIANO**, resolved as it is hereby resolve to enact an ordinance Establishing Bike Lanes Along Strategic locations in the territorial jurisdiction of the City of Sorsogon.

## *City Ordinance No. 03, Series of 2021*

### **AN ORDINANCE ESTABLISHING BIKE RACKS IN IDENTIFIED STRATEGIC LOCATIONS IN THE CITY OF SORSOGON.**

Be it ordained by the 7<sup>th</sup> City Council of Sorsogon in session assembled that;

#### **Section 1      SHORT TITLE**

This ordinance shall be known as **“BIKE RACK ORDINANCE OF 2021.”**

#### **Section 2      DECLARATION POLICY**

It is hereby the policy of the City Government of Sorsogon to promote Public Order and Safety among its constituents. Mobility of Persons is vital, thus there is a need to protect their interest even when outside of their residence.

#### **Section 3      DEFINITION OF TERMS**

**Bike Racks-** a movable device used to safely park bicycles accommodating more or less ten bicycles.

#### **SECTION 4      SCOPE AND COVERAGE**

This ordinance shall include the following;

1. Installation of Bike Racks in strategic locations of the City of Sorsogon

**SECTION 6. IMPLEMENTING AGENCY**

The SK3 and Public Safety Office are hereby directed to ensure full implementation of this ordinance.

**SECTION 7. IMPLEMENTING RULES AND REGULATIONS**

Sixty (60) days upon the effectivity of this ordinance and in close supervision of the local chief executive, the Sk3 and Public Safety Office shall issue an Implementing Rules and Regulations for the effective and efficient implementation of this ordinance.

**SECTION 8. SEPARABILITY CLAUSE**

If for any reason, any provision or provisions of this ordinance be held unconstitutional or declared invalid, other provisions hereof which are not affected thereby shall continue to be in full force and effect.

**SECTION 14. REPEALING CLAUSE**

All ordinances, rules and regulations in conflict with and/or inconsistent with the provisions of this ordinance are hereby repealed or modified accordingly.

**SECTION 9. EFFECTIVITY CLAUSE**

This ordinance shall take effect immediately upon its approval.
