RESOLUTION REQUESTING THE OFFICE OF THE CITY ENGINEER TO CONDUCT ASSESSMENT AND PROVIDE THE COUNCIL WITH THE INFORMATION AS TO THE ESTIMATED FUNDING REQUIREMENTS INTENDED FOR THE REHABILITATION OF DRAINAGE CANAL AND IRRIGATION SYSTEM SERVICING THE FARMERS AND IRRIGATORS ASSOCIATIONS OF BACON AND WEST DISTRICTS OF THE CITY OF SORSOGON

**WHEREAS,** Hon. Franco Eric O. Ravanilla brought out during the January 26, 2021 Regular Session of the 7<sup>th</sup> City Council the issue on the dilapidated irrigation system supposedly servicing the farmers and irrigators associations of Bacon and West Districts;

**WHEREAS,** due to budgetary constraint of the National Irrigation Administration to immediately rehabilitate the dilapidated irrigation system affected by typhoons, the city government of Sorsogon may opt to provide funding for the purpose or may request other government agencies or private entities to outsource funding thereto;

**WHEREAS,** in order to prepare funding requirements if the city government opt to undergo the said undertaking, an assessment of the damage thereto is necessary to come up with the cost estimate intended for the purpose;

**NOW THEREFORE,** on motion of **Hon. Franco Eric O. Ravanilla,** duly seconded by **Hon. Danilo A. Deladia,** resolve as it is hereby resolved to request the Office of the City Engineer to conduct assessment and provide the council with the information as to the estimated funding requirements intended for the rehabilitation of drainage canal and irrigation system servicing the farmers and irrigators associations of Bacon and West Districts of the City of Sorsogon.
