RESOLUTION DECLARING VALID BARANGAY ORDINANCE (RESOLUTION NO. 16, SERIES OF 2020) FROM THE BARANGAY COUNCIL OF BARANGAY BARAYONG, WEST DISTRICT, SORSOGON CITY ENTITLED "NEW BARANGAY TAX ORDINANCE SERIES OF 2020 DATED OCTOBER 19, 2020 OF BARANGAY BARAYONG, WEST DISTRICT, SORSOGON CITY"

**WHEREAS**, Barangay Ordinance (Resolution No. 16, Series of 2020) from the Barangay Council of Barangay Barayong, West District, Sorsogon City was among the items deliberated upon by the 7<sup>th</sup> City Council during the December 15, 2020 Regular Session and was officially referred to the Committee on Rules and Internal Affairs;

WHEREAS, cursory reading of the submitted barangay tax ordinance reveals that the said barangay tax ordinance is within the ambits of the powers conferred to the barangay council by virtue of Section 152 of Republic Act 7160 otherwise known as the Local Government Code of 1991.

**WHEREAS**, the Sangguniang Panlungsod finds the barangay tax ordinance intra vires as mandated by the Local Government Code of 1991;

WHEREAS, foregoing premise considered and after due deliberation on the matter, the 7<sup>th</sup> City Council deemed it necessary to pass a resolution declaring valid Barangay Tax Ordinance (Resolution No. 16, Series of 2020) from the Barangay Council of Barangay Barayong, West District, Sorsogon City entitled "New Barangay Tax Ordinance series of 2020 of Barangay Barayong, West District, Sorsogon City";

**NOW THEREFORE**, on motion of **Hon. Joven G. Laura** duly seconded by **Hon. Danilo A. Deladia**, resolve as it is hereby resolved to declare valid Barangay Tax Ordinance (Resolution No. 16, Series of 2020) from the Barangay Council of Barangay Barayong, West District, Sorsogon City entitled "New Barangay Tax Ordinance series of 2020 of Barangay Barayong, West District, Sorsogon City";
