RESOLUTION ADOPTING AND APPROVING CITY DEVELOPMENT COUNCIL - EXECUTIVE COMMITTEE RESOLUTION NO. 02, SERIES OF 2021 (RESOLUTION FAVORABLY APPROVING THE REALIGNMENT OF TWENTY MILLION NINE HUNDRED SIXTY EIGHT THOUSAND TWO HUNDRED NINETY NINE AND 73/100 (P20,968,299.73) PESOS FROM 2021 20% DEVELOPMENT FUND ITEM NO. 1-2 (LOAN AMORTIZATION) AND II-2 (LOT PURCHASE FOR SOCIALIZED HOUSING) TO ITEM II-3 TO 6 AND ITEM NO. IV-2 AND INCLUSION OF THE SAME IN THE 2021 20% DEVELOPMENT FUND PRIORITY DEVELOPMENT PROJECTS

WHEREAS, on January 29, 2021, the Hon. Ma. Ester E. Hamor, City Mayor, Sorsogon City wrote a letter addressed to the Honorable Members of the Sangguniang Panlungsod thru Hon. Mark Eric C. Dioneda, City Vice Mayor, Sorsogon City respectfully requesting among others,

adoption, approval and enactment of RESOLUTION NO. 02, SERIES OF 2021 OF THE CITY DEVELOPMENT COUNCIL (CDC) held last January 20, 2021 via zoom entitled "**RESOLUTION ADOPTING AND APPROVING CITY DEVELOPMENT COUNCIL -EXECUTIVE COMMITTEE RESOLUTION NO. 02, SERIES OF 2021** entitled (RESOLUTION FAVORABLY APPROVING THE REALIGNMENT OF TWENTY MILLION NINE HUNDRED SIXTY EIGHT THOUSAND TWO HUNDRED NINETY NINE AND 73/100 (P20,968,299.73) PESOS FROM 2021 20% DEVELOPMENT FUND ITEM NO. 1-2 (LOAN AMORTIZATION) AND II-2 (LOT PURCHASE FOR SOCIALIZED HOUSING) TO ITEM II-3 TO 6 AND ITEM NO. WHEREAS, the City Government of Sorsogon was granted by the Land Bank of the Philippines (LBP) for the deferment of principal payments of the city government's loan for six (6) months from October 19, 2020 to March 17, 2021;

WHEREAS, for the period January to March 2021, the total deferment from the loan amortization amounted to Ten Million Nine Hundred Sixty Eight Thousand Two Hundred Ninety Nine and 73/100 (P10,968,299.73);

WHEREAS, the lot purchase for socialized housing in the amount of Ten Million (P10,000,000.00) Pesos will not be implemented this year due to various technical requirement;

WHEREAS, the establishment of eco park will boost the tourism industry in the City once the pandemic is over thus the tourism industry is considered as one of the economic driving forces;

WHEREAS, the projects identified is consistent with the priorities under the Local Development Plan and complements the overall national and global goals and aspirations;

NOW THEREFORE, on incidental motion of **Hon. Nestor J. Baldon**, duly seconded by the **Hon. Franco Eric O. Ravanilla**, resolved as it is hereby resolve to pass a resolution adopting and approving City Development Council -Executive Committee Resolution No. 02, Series of 2021 (Resolution favorably approving the realignment of Twenty Million Nine Hundred Sixty Eight Thousand Two Hundred Ninety Nine and 73/100 (P20,968,299.73) Pesos from 2021 20% Development Fund item no. I-2 (loan amortization) and II-2 (lot purchase for socialized housing) to item II-3 to 6 and item no. IV-2 and inclusion of the same in the 2021 20% development fund priority development projects
