WHEREAS, after thorough evaluation of projects funded and implemented under the 2019 and 2020 20% Development Fund have savings and remaining balances and some projects identified received funding from National Agencies;

WHEREAS, such has a total remaining balance of P25,061.19 and P9,229,080.80, respectively, which needs to be consolidated to supplement the urgent requirements;
