RESOLUTION FAVORABLY ENDORSING THE PROPOSED CONSTRUCTION OF SORSOGON ECO PARK AND BE PART OF THE APPROVED LOCAL DEVELOPMENT INVESTMENT PROGRAM AND THE 2020 AND 2021 ANNUAL INVESTMENT PLAN OF THE CITY OF SORSOGON

**WHEREAS,** the Sangguniang Panlungsod was in receipt of a letter from the Hon. City Mayor Ma. Ester E. Hamor, dated January 29, 2021, requesting the members of the 7<sup>th</sup> City Council for the passage of a resolution favourably endorsing the proposed construction of Sorsogon Eco Park and be part of the approved Local Development Investment Program and the 2020 and 2021 Annual Investment Plan of the City of Sorsogon;

**WHEREAS,** in consonance with the Local Budget Circular (LBC) No. 123, dated February 17, 2020, the city government of Sorsogon has an appropriation of P 20,898,428.00 which shall be used to fund the construction, rehabilitation, repair or improvement of the public open spaces;

**WHEREAS,** the same is in accordance with the Special Provision (SP) No. 2 of the Local Government Support Fund (LGSF) in the FY 2020 General Appropriation Act (RA No. 11465);

WHEREAS, every local government unit shall exercise the powers expressly granted, those necessarily implied therefrom; as well as powers necessary, appropriate or incidental for its efficient and effective governance and those which are essential to the promotion of the general welfare. Within their respective territorial jurisdiction, local government units shall ensure and support, among other things, the preservation and enrichment of culture, promote health and safety, improve public morals, enhance economic prosperity and social justice, maintain peace and order and preserve the comfort and convenience of their inhabitant;

**NOW THEREFORE,** on motion of **Hon. Nestor J. Baldon**, duly seconded by the body, resolve as it is hereby resolved to favorably endorse the proposed construction of Sorsogon Eco Park and be part of the approved Local Development Investment Program and the 2020 and 2021 Annual Investment Plan of the city of Sorsogon.
